#### **IMPORTANCE OF GIRL'S EDUCATION ON CLIMATE ACTION**

CONSEQUENCES OF CLIMATE CHANGE AND ENVIRONMENTAL DEGRADATION, AMONG OTHERS, HAVE BEEN FOUND TO HAVE NEGATIVE IMPACTS ON GIRLS' ACCESS TO BASIC EDUCATION, WHICH IS KEY TO ACHIEVING GENDER EQUALITY.
