GENERAL INFORMATION

The UK is a world-leading provider of transnational education (TNE) programmes with approximately 360,000 students actively enrolled in such programmes overseen by around 80 per cent of UK universities; as a result, UK TNE is expanding across the globe. According to British Council's 2013 research paper "The Shape of Things to Come – the Evolution of Transnational Education", Thailand is defined as a country with considerable potential to develop its own TNE programmes.

Recognising the potential of expanding TNE models in Thailand, British Council is proposing support for the delivery of one-year, two-phase TNE programmes designed to increase education links between Thai and British institutions which could help provide solutions to national policy and market challenges and contribute to an internationalised environment and economic benefits for both the UK and Thailand.

The programme is delivered by British Council in collaboration with Thailand's Office of the Higher Education Commission (OHEC) and nine Thai research universities

TRANSNATIONAL EDUCATION SEED FUNDING

Transnational education seed funding is part of the UK-Thailand Transnational Education Development activity. The aim is to provide small-scale seed funding for collaborations between the UK and Thailand to develop new links in TNE.

This programme is designed to be flexible and responsive to both countries' needs, allowing applicants to establish TNE programmes in specific areas linked to country priorities and development needs.

The successful transnational education seed funding applicants for 2015/16 are as follows:

MSc Biotechnology; MSc Biotechnology + Pharmaceutical Science; MSc Biotechnology + Medical Technology Dual Award MSc Our long-term plan is for Institution-wide, double awards at Bachelors, Masters and PhD across a range of subject areas, plus staff and student exchanges. The specific objective for this award is to establish a two-year, dual (double) award MSc in Biotechnology with the Faculty of Life Sciences (Liverpool) and Faculties of Science, Pharmaceutical Science and Allied Health Sciences (Chulalongkorn). The Dual Award will incorporate the 1 Year MSc at Liverpool and the two-year awards at Chulalongkorn, to give the three named pathways. The initial three pathways will be: Biotechnology; Biotechnology (Pharmaceutical Science); Biotechnology (Medical Technology).

Students will spend year 1 at Chulalongkorn taking jointly-approved masters modules. At the end year 1, they will have the option of a year at Liverpool, and enroll on another set of approved modules that both constitute the Liverpool award and contribute to the Chulalongkorn award. This would give a 1 + 1 Dual award. Alternatively, students may spend their entire second year at Chulalongkorn (2+0 Dual award), or perhaps part of their time at Liverpool. Any study pattern is acceptable, but we would encourage Thai students to spend some time at Liverpool. We envisage that highly-successful MSc students will be "fast-tracked" onto a Dual PhD programme.

Ph.D. in Science and Technology

The proposal is on the development of a double doctoral degree. Through the seed fund, we will look into the details of the doctoral degree regulations in each of the two universities and the experience of the students throughout their degree life cycle (4 years full-time).

Through this programme, the applicants with excellent academic track record, through a highly competitive scheme, will be able to experience doctoral research to be carried out in parts at the two universities. An important feature of this programme is the students' exposure to the complementary nature of research methodologies offered by the two Faculties and the training/development programme of wider skills at the university level. This prepares the graduates with essential attributes to communicate at International level.

Both universities, University of Reading and KMUTT, aims to be global universities. One of the key strategies is to develop research and teaching partnerships with international higher education institutions and the one of the core processes is to produce competence graduates. Therefore, the linkage through the core process between institutions will enhance students' international experiences and the success of the programmes. The students from both universities will have more international experience not only the academic aspects but also the cultural aspects through this partnership with TNE Programme support. For Thai students, especially under the Microbiology programme which is the 2nd largest programme in Faculty of Science, KMUTT, will have a chance to attend world-class programme at University of Reading. It is also expected that the programme will create the visibility of the faculty and attract more qualified students to Microbiology programme at KMUTT. Students from University of Reading will be invited for summer internship experience at KMUTT which usually conducted during the summer (June to July). Through this special programmes designed by the Faculty of Science, KMUTT, the UoR students will be provided with the international experience as well. This TNE programme of KMUTT with University of Reading will be a positive step in initiating BSc dual degree programme. If the programme is successful, the model could be extended to other interested degree programmes between both universities. The activities will be designed for not only for the development of TNE programme but also provide the opportunities for professors and staff to collaborate and discuss the strengths and the steps necessary to formalise more cooperation and collaboration on the existing relationship. Other educational and research collaborative activities will be encouraged through this programme and further strengthen the bond between both universities which will eventually exceed the objective of TNE Programme.

Bachelor of Science

The objective of this programme is to create worldclass scientists, with the academic expertise, international experience and language/transferable skills to address global scientific challenges.

Sussex regularly ranks in the UK's top 20 and world's top 200 universities, with particular strengths in Life Sciences, the University's largest school with an annual research income of >£13M. The School of Life Sciences is at the forefront of research in the biological sciences in the UK, coming in the top 10 in the REF 2014 and has an extensive teaching portfolio across a range of biological disciplines. All Life Sciences courses are rated within the top 10 in the Times Good University Guide 2016.

Mahidol is ranked in Thailand 431st in the world. The Faculty of Science already offers leading international programmes, including Double Degrees, in distinctive relevant fields, including Biomedical Science, and Bioresources and Environmental Biology. Global partners include the State University of New York, Universite du Maine, and Curtin University.

Mahidol and Sussex have successfully launched a BSc in Biomedical Science which provides students with a 3.5-year Single or 4-year Double Degree (2+2) - with potential to progress to postgraduate study. TNE funding would allow both universities to set up new programmes in Biological and Environmental Sciences, while also facilitating academic collaboration and future programme development in Pharmaceutical Science, Neuroscience, and Biotechnology.

This Transnational Education Programme between Mahidol University and the university of Strathclyde will establish and develop a range of high quality dual degree programmes in the fields of Biomedical Engineering, Chemical Engineering and Mechanical Engineering. It will promote higher educational opportunities to qualified students for studying in an overseas or exchange programme environment where they can expand knowledge and experiences beyond their local contexts. There will be exchange of faculty members in terms of teaching and research activities and there will be collaborative research activities, seminars and a Mahidol-Strathclyde Symposium.

Suranaree University of Technology (SUT) is aiming to reach the new level of higher educations; therefore, SUT proposed a numbers of TNE development programmes, including engineering, agricultural business management, and science. To start with the TNE, the bachelor degree of engineering is now under the developmental process. Noteworthy, this TNE programme in engineering is in accordance with the current Thailand national developmental plan, including infrastructure for public transportation, vehicle technology, and alternative energy resources. Once the programme is established, SUT could see numbers of potential benefits, at both national and global levels. This TNE programme could lead to a dynamic academic activity of SUT with the University of Birmingham (UoB), and technology exchange/transfer between the two universities. The long-term sustainability of TNE programme at SUT can be achieved by several ways. TNE programme can be extended to other disciplines, such as Agriculture and Science. In addition, joint research projects and students exchange between SUT and UoB are expected to be happened in the near future. Importantly, in order to increase the target, this international TNE programme will not only serve Thais, but also AEC students, who would like to conduct their bachelors in engineering. From the aforementioned background, SUT believes that this TNE programme in engineering will be impact and valuable for Thailand as a whole.

Joint Programme between CICM and QMUL

Master of Science in Aesthetic Medicine (M.Sc. in Aesthetic Medicine) Double/Dual Degree Programme

Chulabhorn International College of Medicine (CICM) and Queen Mary University of London (QMUL) are cooperating to create several joint programmes on Medical and Health Sciences in order to produce potential personnel who can be specialised in terms of Medical and Health Care Services.

The first programme which needs to be introduced is the Master of Science in Aesthetic Medicine (M.Sc. in Aesthetic Medicine). This Post-graduate programme will be considered as a Double/Dual Degree offered by our two institutes. Duration of study is approximately two years. Non-clinical part will take place at QMUL and the clinical part will take place at CICM Thammasat University, Thailand. At the first stage, we aim to accept 20 students per year. The first batch starts in this coming academic year 2017. Our tentative outline of this programme begins with the negotiation period which will be in April, 2016. Then, contract signing ceremony and the committee set will be from May to December, 2016. The programme ought to be approved by the University Council in June, 2017. After that, the application process will be announced in September, 2017. Admission examinations until the opening of new semester should be before August, 2018

In the second phase, we have planned to settle down our CICM-QMUL Collaboration Center in our own campuses to create more convenience in terms of educational service. International Quality Assurance will be approached to meet the standard of education. We have also planned to have our future collaborative programmes on Public Health, Science and Technology, and Engineering. Hence, we hope that our joint programs can lead people to the bright future of international medical education.

During her years in the Ministry of Foreign Affairs, H.E.Mrs. Pinthong served in the Economic Affairs Department, the European Department, the Department of ASEAN Affairs and the Institute of Foreign Affairs. Prior to the appointment as Deputy Permanent Secretary, she was Director-General of Thailand International Development Cooperation Agency (TICA). H.E. Mrs. Pinthong served as Ambassador to the Kingdom of Norway from 2004 to 2007, with concurrent accreditation as Ambassador As the first Director of Educational Quality to Latvia.ln 2011 -2012, she was Thailand's Eminent Person in ASEAN-US Eminent Persons Group and ASEAN- INDIA Eminent Persons Group. She received her doctorate in has experience as an education accreditor



Dr. Duong Mong Ha Rector, VN-UK Institute for Research and Executive Education The University of Danang

Dr. Duong Mong Ha is currently the Rector of the VN-UK Institute for Research and Executive Education - University of Danang, which was established in November 2013 under the Joint Statement of Higher Education in various locations in the world. Cooperation between the Vietnamese and the UK governments. He previously served as Director of International Cooperation and Director of Educational Quality Assurance at the University of Danang (UD).

Through his role as Director of International Cooperation, he developed many collaborative programmes between UD and overseas institutions, successfully implementing many educational projects such as WB Higher Education Projects and NGO projects at UD.

In November 2013, the VN-UK Institute for Research and Executive Education, the first phase of VN-UK University, was established and he was appointed Rector.

He originally graduated with a Bachelor's of Engineering from Danang University of Technology, and has also received a Master's of Education (by research) from the University of Melbourne and Doctorate of Education from La Trobe University, Australia. His teaching and research experience includes developing the field of mechanical engineering, assessment and evaluation, project management, educational administration and quality assurance



Mr. Jon Pike Director of Internationalisation of Westminster Business School, University of Westminster

Jon Pike is Director of Internationalisation in the Westminster Business School, University of Westminster, London. Prior to taking up this position, he was Director of Postgraduate around the world. The role also requires Studies within the School and, before that, was Course Director of the Masters in Marketing Communications at Westminster Business School, which he joined in 1999. His specialisation is market and media research, coupled with integrated marketing communications.

In his current role, Jon is responsible for devising, developing and implementing Business School international strategy, in line with overall University strategy, on which he works closely with Deputy Vice Chancellor for Global Engagement and other senior managers. This involves participation in various University committees to represent international aspects of teaching, learning and operations.

Prior her PhDs, Suparak holds both bachelor (BSc) and master (MSc) degrees from University of Maryland, USA. She had over 14 years of professional experiences with multinational corporations and governmental agencies abroad and in Thailand.



Prof. Tony Downes Provost and CEO. University of Reading Malaysia

Professor Tony Downes is Provost and Chief Executive Officer of the University of Reading Malaysia, and is also a Professor of Law. He has worked at the University of Reading since 1990 and was previously Deputy Vice Chancellor of the University, twice serving as Acting Vice Chancellor. As Deputy Vice Chancellor, Professor Downes had responsibility for planning and operational issues throughout the University. In 2008 he first initiated, and then chaired, the Reading-Malaysia project, and so has been a regular visitor to the region since that time.

Educated at the Universities of Oxford and Aix-en-Provence, he began his career as a lecturer in Law at the University of Durham and as Visiting Professor at the University of Iowa before joining the University of Reading as Reader in European Community Law in 1990. Subsequently he has held a number of senior posts within the university, including Dean of Faculty and Pro Vice Chancellor. He was appointed Provost and Chief Executive Officer of the University of Reading Malaysia in 2012. He and his wife have been resident in Malaysia since January 2015.



Prof. Troy Heffernan International Centre Director Academic Partnerships, Plymouth University

Trov Heffernan is Professor of Transnational Education and Director of the International Centre at Plymouth University. His pioneering research into transnational education has led to numerous invitations around the world to run workshops and presentations to enhance best practice in the field. Other research streams he explores are lecturer effectiveness and student employability enhancement. His research-led approach to education has resulted in the development of a range of new programmes and initiatives between Plymouth University and partners around the globe.

For his contributions to enhancing learning and teaching Professor Heffernan ha received various awards including t Australia and New Zealand Marketin Educator of the Year (2004), the University of Plymouth Inspirational Teaching Award (2010) and the Exceptional Partnersh Award (2012). He has over 50 international publications, and has published in journ such as the Higher Education Review, International Journal of Management Education and the Journal of Higher Education Policy and Management.

The Office of the Higher **Education Commission**

The Office of the Higher Education Commission (OHEC), Ministry of Education, Thailand is responsible for managing higher education provision and promoting higher education development on the basis of academic freedom and excellence. Its mandates are to formulate policy recommendations and higher education development plans, set higher education standards in line with international standards, provide recommendations on resource allocation framework for higher education development, and monitor and evaluate outcomes of higher education management.

OHEC is directed by the policy advisory body called Higher Education Commission. Their responsibilities include proposing higher education development policies and plans in line with the National Economic and Social Development Plan and National Education Plan, supporting allocation of resources, and monitoring and evaluation of higher education provision. Moreover, the Commission provides recommendations on the issuance of HE regulations, criteria and announcements, and provides comments and recommendations to the Minister of Education or Council of Ministers.

At present, Thailand has a total of 156 higher education institutions. Among this number are 81 public higher education institutions consisting of 19 autonomous universities, 15 traditional universities (including 1 community college; 20 campuses), 38 Rajabhat Universities (formerly teacher training colleges), and 9 Rajamangala Universities of Technology (former technical colleges), together with 75 private higher education institutions. The student population in higher education is over 2.2 million. In addition to the institutions under the jurisdiction of the Office of the Higher Education Commission, Ministry of Education, there are specialised higher education institutions under the auspices of other ministries.

The University occupies a 456-acre tract of land that was granted by its founder. The exchange of faculty members is highly pro-active. concentrating on in-bound academics being invited to teach two-week modular courses in our international programmes. We anticipate that all the international activities of Chulalongkorn University will increase exponentially in the next decade.
